

- The Rape crisis center informed the collaborative about two clubs in their organization, "MY Strength" a club for young men where they can attend and talk about traditional manhood and "Be Strong" a young women's club that provides how to have healthy relationships and empowerment. They will be having a task force on January 26<sup>th</sup> from 4-5pm and are looking for people in the community who are invested in the youth in Riverside County. They will be talking about their organizations and would like to have attendees provide feedback on how they can improve the clubs.

5. **HOPE Updates:**

**HOPE for the Holidays donation for Foster Youth:** Sharmil updated the collaborative on HOPE for the Holidays; over 450 toys were donated valued over \$4400 towards our in-kind match. Apart from toy donations, HOPE was able to fundraise \$8,360 for the older foster youth aging out of the system. The My Stuff Bag foundation also donated 140 bags for kids that are in crisis, the bags included age and gender appropriate toys, books, clothing personal toiletries and handmade blankets; which valued to \$11,552. A total of approx. \$24,000 was raised cash and in-kind in this campaign alone.

**Regional Collaborative Budgets:** FSA staff member reminded the collaborative about their \$10,000 budget and provided the members with an updated spreadsheet that includes all of the collaborative expenses and remaining balance.

**Budget Parameters:** Sharmil Shah informed the collaborative about the Board of Supervisors requesting to set some budget parameters on how the money is being used. There are certain percentages that should be used for certain things. Parameters will be discussed with all the chairs, once the HOPE Board president signs them we will announce in detail what the percentages are by next meeting.

- Chair of the collaborative announced he will be stepping down as chair. Sean shared his experience as the chair and would like to see a community member lead this collaborative.
- Collaborative Officer Role Description form was provided to members, Sharmil added that the chair position is required to lead the collaborative meetings, sit and attend the HOPE Board meetings. If anyone is interested in taking this position please let us know, or if you know of anyone who may be interested please share this information.


