## 4. BACA Presentation

- i. Baca has been around since 1995, it is a non-profit organization and it serves about 17 countries, and 48 states.
- ii. The main goal of BACA is to empower children who have been victims of abuse and provide them with safety and support during difficult times.
- iii. The organization has a referral process, through their child liaison who screens if the child will be a good candidate for BACA. Children cannot self-refer they must be referred by a parent or legal guardian.
- iv. Once the referral is made BACA then goes through approval process, through their board and makes the decision if the case is a good case or not. Children must be under the age of 18 to qualify.
- v. All of BACA members go through an extensive background check through the Department of Justice and also complete several trainings before working with children.
- vi. BACA is all volunteer based, members in BACA have different professional backgrounds such as upper management for large companies, engineering, and law enforcement.
- vii. Average time frame for services, is usually the same day, once the case is presented to their board and it is approved through them.
