- a. Meeting was called to order at 9:32 am by Nicole Nevarez.

2. Review and Approve September Minutes

- a. **Victoria makes a motion to approve with corrections, Robin seconds – All approved**
with the following corrections:

 - ii. 5g – correct senate member to assembly member
 - iii. 6b i. – correct “the” to “they” and market to “marketed”

3. Community Survey

- a. Nicole asked all collaborative members to fill out survey regarding HOPE collaborative (per FSA).

4. Expenditure

- a. Funding request was submitted by Alanna.
 - i. Request form presented by Alanna Gonzalez (Jurupa Unified School District), series of workshops, “Protecting Our Youth” includes a series of speakers on various topics including, bullying, human trafficking, internet safety, and self-injury. Requesting \$40 for continental breakfast for 4 sessions, a total of \$160 for all sessions. Community members, parents, educators will be invited. Morning event, January would be next session
 - ii. Related to collaborative sexual, physical and emotional abuse.
 - iii. Victoria asked if this would be a sponsorship.
 - iv. Nicole clarified we have money to spend \$2,142 for sponsorship funding per expenditure report.
 - v. Carol, “How will HOPE be acknowledged if we approve?” “How will HOPE’s name get out at the event?”

- vi. Alanna suggested HOPE brochures be presented at the event and the collaborative be thanked verbally afterwards, historically HOPE has supported this event.
- vii. Victoria does not remember District 2 supporting – Carol seconded.
- viii. Robin suggested HOPE have a booth at the event.
- ix. Robin motions to approve \$160 for continental breakfast for Jurupa Valley Unified workshop series – Seconded by Stephany Owens.**
- b. Nicole suggested purchasing materials for the event and future events.
 - i. Robin suggested to table a purchase request due to Anita’s absence, Carol seconded the motion.
 - ii. Carol asked about Mandarin outreach material.
 - iii. Nicole informed the collaborative this this would only be possible in large quantities.
 - iv. Carol asked where the material options could be viewed.
 - v. Nicole stated positivepromotions.com, forimprint.com.
 - vi. Victoria suggested looking at childrenspartnership.org for pre-made, personalized material, where HOPE’s logo could be copied onto.
 - vii. Robin suggested collaborative do research and bring any favored materials to next meeting for consideration.
 - viii. Victoria suggested making outreach materials and giveaways a topic for next meeting
 - ix. Victoria asked if any research has been conducted as to which materials are most popular for distribution.
 - x. Robin suggested bigger giveaway items (coin purse), Carol seconded that it was beneficial move and better marketing –Victoria seconded.
 - xi. Nicole suggested forimprint.com, for chip clips, hand sanitizer, bigger items, etc. She encouraged all collaborative members to come together for December to come up with expenses, because the year is almost over and the collaborative has not spent any money.
 - xii. Victoria suggested MonkeyJoeSpeak for outreach material.
 - xiii. Deanne suggested Nicole to bring inventory for next meeting to see what exactly needs to be ordered.

 - i. Nicole reported board could not approve sponsorship because they did not see a correlation between goals of collaborative.
 - ii. Nicole suggested Victoria attend open board meeting for discussion.

It is part of the DPSS and they write grants to the state to help families and housing and they were both at the board youth meeting, this took place at Safehouse they are looking for youth to be on the board from ages 18-24 who have previous experience on homelessness. They only have one person in Jurupa valley. If interested they can contact Luisa.
 - a. There is a big grant coming down a Seventy-five-million-dollar grant in Riverside County. Tania Turnor with the housing authority is the lead on this. The housing program for youth, will assist with beds and services for homeless youth.

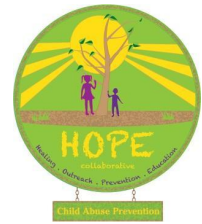

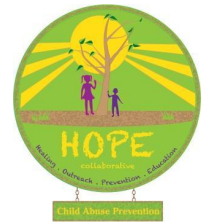

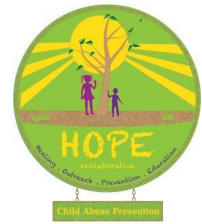
